Museveni ordered the murder of Capt. Chris Mukasa and two US citizens 'to tarnish Amin'

Dear Radio Munansi,

I am a former agent of **GSU (General Service Unit)** and later on served in the State Research Bureau until 1979, when we ran to exile in Kenya, where we were arrested and brought back to Uganda. I was held in then Nile Mansions hotel (now Speke hotel) and later transferred to Luzira Prison.

Myself and others who had served in the GSU were released by the late Lt. Kato (who died in the chopper crash with Oyite Ojok) and integrated into the **NSA (National Security Agency)** of Obote II to help with training and coordination of that new intelligence body.

Now, the story of this late Captain Christopher Mukasa has a lot to do with the death of the two Americans (journalist Nicholas Stroh and a Makerere lecturer Robert Siedle) and I do encourage the American Government to reinvestigate this case before all the key witnesses die since they are at advanced ages. As we all know, there is no statute of limitation in a murder case.

Captain Mukasa was killed on the direct orders of Yoweri "Kaguta" Museveni by Lt. Silver Tibihika. This same Tibihika had earlier on killed the two Americans also on orders from Museveni to tarnish the image of Amin. **These are not mere smear allegations but facts which we all urge the U.S. government to investigate**

This Lt. Tibihika was a ruthless killer and he is not only responsible for killing the Americans and Capt. Mukasa but many prominent politicians, businessmen, church leaders and elders in Masaka and Mbarara on behalf of **FRONASA** ruthless murder organization which was under the control of Yoweri Museveni.

Ugandans should not be fooled by Yoweri and company. As a member of SRB (and later NSA), we did investigate Yoweri Museveni and his criminal activities in Uganda during Obote I (1966 – 71), throughout Amin's time (1971 – 79) and during the time he was fighting in Luweero 1981 onwards.

For the sake of Ugandans and those interested in finding out the activities of FRONASA and Museveni, some of the first things Museveni did when he returned from exile was to access all military and police barracks and offices and **burn all documentation**. Later, he ordered the burning of files in Republic House (former General HQ of the Army) *in*

his bid to cover up his crimes.

After Kampala fell to the invading troops in 1979, he was the first government officer to go to State Research Offices in Nakasero and collect all the super secret and classified files and to date, no one can place a finger on where he took them.

We should ask ourselves, why up to today, if the State Research Bureau was that notorious and bad, their activities and files have never been handed over to the so-called Human Rights Commissions and their activities made public! (*Incidentally, we get letters all the time from anguished Ugandans looking for any news about their loved ones who disappeared during Amin's regime, kumbe Yoweri and his co-conspirators are hiding this data! WHY? -Ed*)

Secondly, I do not know if Brig. Ali Fadhul is alive or dead (though someone told me he had been hanged on the orders of Museveni while in Luzira). This was all done to hide the truth since he Fadhul knew who had killed the Americans and many prominent Ankole people. **Brig. Ali Fadhul is still alive and am sure he knows much more about Museveni and his activities since he M7 himself has made several references about him**

Ugandans should like to know as from today that the same Museveni is now in the process of dismantling the Police Special Branch Unit against the will of the Parliament we are told, but why?.

Chris Rwakasisi had also carried out extensive investigation on the criminal activities of Museveni and hope he does not die before he tells the world his side of the story. (*Chris Rwakasisi, Minister of Internal Affairs in the Obote II regime is on [death row in Luzira Prison](#). He is now a devout Christian -Ed*) **Rwakasisi was released by Museveni on condition that he never speaks or talk about Luwero triangle and since both are made of the same mold, he agreed.**

Captain Mukasa had carried out a professional investigation, which he was due to present to cabinet and the American Embassy, which was still here at that time (*The United States closed its embassy in Kampala around 1973 -Ed*). His going to Mbale was to investigate a tip he had got from someone within the FRONASA camp who was willing to give evidence that Lt. Tibihika was involved in the murder of the two Americans on orders of Museveni.

For your information, Captain Mukasa was also leading the fight to arrest the FRONASA boys training and hiding in Mbale and the Eastern Region.

The same source within FRONASA was also helping Mukasa to arrest Museveni on one of his visits in Mbale and he almost succeeded. (*This could be the cause of the narrow escape described in Yoweri's book [Sowing The Mustard Seed Chapter 7](#), under 'Tragedy*

Ugandans should also know that Museveni and his FRONASA boys are responsible for the killing of Shaban Nkutu in 1973 (see [Amin victim found in mass grave](#) -Ed). This was not the work of Amin as most people have been led to believe. This is not true and the same Captain Mukasa fully knew that. **Eliminate the threat and blame your enemy this method of operation M/O has worked for Museveni on all crime scenes he has prints, in the 1970s it worked for him in Mbarara and Masaka, in 1980s it worked in Luwero, in the 1990s it worked in Gulu, Sudan, Rwanda and Burundi, in 2000s it worked in Congo and now Somalia. Terrorize civilians and accuse your enemy.**

When I first read the book, I had the feeling that my relative's disappearance might have come about as a result of this incident. This now explains why Amin made the announcement that he did on Radio Uganda. True, he went to Mbale on a serious mission because for the first time in a very long time he put on his army uniform was well armed. He must have been betrayed.

Do you know where he was killed and where his remains might be? His body guard or driver as it were just brought back his army boots and his briefcase. Might you know who this man was and where he is today? I remember later in the 1970s he was deployed SRB to Tororo and used call himself ANYOGOGA as his Nom de guerre. Maybe he might tell us how my relative was killed. It is not only sad but very very painful to find that a man (Museveni) the family supported whole heartedly is the one who killed our relative.
